The Maltese Dialogue is the first comprehensive treatise of the history, institutions, and political projects of the Order of the Knights of Saint John of the Hospital, commonly known as the Maltese Order. It was written during the tenure of Grand Master Fra Claude de la Sengle (1553-1557), although the conversation between Commendator Fra Giuseppe Cambiano, one of the Order's most prominent sixteenth-century functionaries, and three Venetian patricians, on which the Dialogue is based, may have taken place even earlier. The contents of the Dialogue fall in three categories: the opening section is the first detailed precis of the Hospitallers' history; then comes the bulk of the treatise, presenting a concise summary of the Order's constitution, institutional and legal organization, election procedures, recruitment of knights, rituals of instalment, and financial matters. The remaining section is a polemical exposé arguing for the benefit of the Order's abandoning of Malta and the recapturing of Tripoli. The Dialogue offers a hitherto unexplored, first-rate source on the Maltese knights' self-projection as a unique transnational institution of early modern Europe in the era of nation-states, on the power plays of the major political agents in the sixteenth-century Mediterranean, and on Western Christian strategies of engagement of Ottoman imperialism at the peak of its expansion in the region. Those interested in the history of Christian-Muslim interaction, the evolution of crusading practices in the era of early modern predatory warfare, and the construction of historical memory on the case study of the longest-lasting, and still extant, knightly order, will find it to be a highly intriguing and informative reading. Other contributions include an evocative short story, "Es el agua," by Rolando Hinojosa and reproductions of a recent series of Liliana Wilson Grez's drawings and paintings. An assemblage of extracts from the complete works of Charles Dickens, including his speeches. The volume reflects the editor's effort to include every notable/quotable passage or short comment by Dickens on a subject which interested the great author. It contains over 860,000 words, and there are over 50 illustrations. Included are 27 extended extracts, largely from the fictional works, which capture the greatest scenes in the oeuvre, including the trial of Bardell v. Pickwick, Ralph Nickleby's frustration and suicide, Jonas Chuzzlewit's murder of Tigg Montague and its aftermath, and Mr. Micawber's demolition of Uriah Heep. This reference has over 405 topic captions, or subject headings, organized in 15 chapters: Ages of Man; Body; Mind; Letters and Communication; Spirit, and Moral Qualities; Fellow Man, in Relation; Humankind, in Activity; Three Professions (clerical, legal, and medical); Industry and Government; London; The Rest of the World; Transportation and Travel; Nature, Charles Dickens Self-Revealed; and First and Last Things. Each chapter is provided with a table of contents which constitutes a detailed, fully paginated index of captions and sub-captions, showing the source for each item. In addition, there are exhaustive indexes of Words and Phrases and Localities. This is a companion volume to *Everyone in Dickens*, Volumes I, II, and III.

Caravaggio was one of the most important Italian painters of the 17th century. He was, in fact, the wellspring of Baroque painting. In Hibbard's words, Caravaggio's paintings "speak to us more personally and more poignantly than any others of the time". In this study, Howard Hibbard evaluates the work of Caravaggio: notorious as a painter-assassin, hailed by many as an original interpreter of the scriptures, a man whose exploration of nature has been likened to that of Galileo. La figura de Ortega qua filósofo-ciudadano es el eje de este libro, que nos sitúa ante una alternativa ineludible: o reconocemos que Ortega ha superado fórmulas filosóficas, intelectuales y políticas inservibles para construir una nación democrática o, por el contrario, seguimos instalados en la ideología que lo convierte en un pensador sospechoso de haber caído en todos los males del progresismo o del conservadurismo. Los combates en torno a su genio en la vida pública fueron siempre tan fieros que resultaba difícil saber exactamente sobre qué debatían los contendientes. Quienes hablaban a su favor, a veces, eran considerados progresistas y otras, reaccionarios; al poco tiempo se cambiaban los papeles: los que hablaban bien de él eran llamados reaccionarios, y quienes lo hacían en contra, progresistas. Durante la Transición, y aún hoy, estaban los «liberales» de sangre roja nunca dispuestos a perdonar -lo dicen así ellos mismos- que Ortega hubiera regresado a la España de Franco. El ruido de ese falso debate impedía averiguar las grandes aportaciones del filósofo para superar los males de nuestra época. Este libro defiende tres tesis. Primera y fundamental: Ortega está fuera de la agenda cultural y educativa de España, porque se rechaza su principal aportación a la filosofía política, a saber, la crítica al idealismo es vacía sin el cuestionamiento de la experiencia «totalitaria» (comunismo y fascismo) y morbosa (populismo y nacionalismo) de nuestra época, y viceversa: la crítica al totalitarismo y el populismo es ciega sin el rechazo del idealismo, es decir, de las perversidades que lleva aparejada la modernidad. Segunda y dramática: su idea de España ha fracasado estrepitosamente entre las élites intelectuales y políticas del postfranquismo; no se refiere a un «fracaso subjetivo» sino a la derrota de una sociedad que ha dado la espalda a su mayor pensador. Tercera y paradójica: su pensamiento es tan actual, su vigencia tan filosófica, que sigue siendo el filósofo más leído de España. Su influjo es de tal consistencia entre los grandes escritores y filósofos del siglo XX que no se concibe nuestro tiempo sin Ortega. Su «escuela» no tiene parangón en el siglo XX ni por el número ni por la calidad de los discípulos que, a veces, consiguen superar al maestro. Las «pruebas» filosóficas de El gran maestro se ordenan en tres apartados. El primero construye una crítica a la ideología sobre el filósofo Ortega. El segundo se centra en su retirada de la vida política. El tercero muestra la revisión del filósofo de su propia obra. He aquí un recuento filosófico de su filosofía política como teoría de la democracia. Es su principal legado para que una sociedad construya, quizá reconstruya, su bien común más deteriorado: el Estado-nación, una España democrática de seres humanos libres e iguales ante la ley, en el espacio supranacional de la Unión Europea.
