'Homegardens' are integrated tree-crop-animal production systems, often established on small parcels of land surrounding homesteads, and primarily found in tropical environments. It summarizes the current state of knowledge on homegarden systems, with a view to using this knowledge as a basis for improving both homegardens and other similar multistrata agroforestry systems.
