The author provides a coherent explanation of the proprietary effect of money transfers whether made via the physical transfer of coins or banknotes or, as is now more common, through a bank transfer system. The final section of the book considers how a person can enforce his or her property rights in money, and the legal remedies open to him to recover his money once it is in the hands of a person who is not entitled to it.
