**September 2** Feb 27 2020 Court verdict by Giovanni Antonio Schizzati, nobleman of Piacenza, in favor of Pietro Giorgio III Lampugnani concerning unpaid rent owed by Count Ottavio Del Becco. Lampugnani was represented by Francesco Maria Toferi, while Del Becco was represented by Pietro Francesco Attolini and Tommaso Ravasini, both absent during the verdict proclamation. The court ruled that Del Becco, who was not paying rent to Lampugnani since 1681, was to pay two statoria of sifted corn and two libre of white wax every year on St. Michael's day. Notarized by Ferdinando Pugnelli(?) on 1713 September 2, with his notarial stamp.
