and to identify assurance service opportunities: Client Strategy Templates and Balanced Scorecards. The Tenth Edition of Auditing continues to provide students a balanced presentation of auditing concepts and procedures. The text reflects the challenges inherent in accounting and auditing practice, particularly in public accounting firms. The text is designed to provide flexibility for instructors; the thirteen chapters focus on the Auditing Process while the eight modules provide additional topics. There are three main approaches to teaching auditing, which you need to understand to match customer needs with our texts: 1. The Balance Sheet Approach-smallest market segment and more traditional, which teaches the audit procedures by using the individual balance sheet (and related income statement) accounts. This is an emerging area in auditing that considers audit risk, which is the probability that an auditor will give an inappropriate opinion on financial statements. 3. The Cycles Approach, which was first introduced by the market-leading textbook written by Arens/Loebbecke (Prentice Hall). Cycles are sets of accounts and business activities that go together in an accounting system. This is where Robertson fits in the market.
