They can be described as "social dilemmas" according to Holzinger, 2003. Based on this definition, it is possible to identify a discrepancy in between what is regarded rational on an individual level and the collective common "good." Therefore, in a collective action problem micro-level behaviour translates into undesirable macro-level effects, which manifest in decreased collective welfare.
